Report on Supplementary Matters Arising from an Audit Engagement

To the Minister of Western Economic Diversification

In accordance with the financial contribution agreement dated March 6, 2018, we have been engaged to report on the supplementary schedule included in Schedule 1 for the year ended March 31, 2019 (the "other reporting responsibility"). This other reporting responsibility relates to our audit of the non-consolidated financial statements of the Community Futures Development Corporation of the North Okanagan for the year ended March 31, 2019, on which we issued our report dated June 19, 2019. Management has prepared the supplementary information.

This report has been prepared in accordance with Canadian Standard on Related Services (CSRS) 4460, *Reports on Supplementary Matters Arising from an Audit or a Review Engagement*.
